WARRANTY AND INSTALLATION INSTRUCTIONS

CO-EXTRUSION HIGH PERFORMANCE 3RD GENERATION WRAPPED DECKING

Co-extrusion deck boards have been engineered over the last few years & they are now manufactured with a high-performance shell wrapped around a composite hardwood solid internal core to protect it from the elements, providing higher resistance to fading, staining, scratching & mould. The Honorwood high quality core uses only premium recycled HDPE mixed with HARDWOOD timber fibres. Beware of competitors using softwood or bamboo and only PE mixed within their core.

It is always recommended to use 400-450mm centres for your joists in residential applications and 350mm for commercial. The wood grain finish is regarded as one of the best comparisons to timber that you can buy in the composite deck industry and far superior to other leading brands.

By using solid deck boards, it is much stronger than hollow or "M" boards or 2nd generation solid composite decking found in Australia.

In addition to improved performance, the shell technology includes a higher UV rating and offers:

- Easier maintenance: requiring only an occasional cleaning with soap & water or a pressure washer.
- Enhanced aesthetics: richer, long-lasting color palettes & natural embossed timber grain patterns.

In plain English consider this co-extrusion deck as a Mercedes car of the decking industry.

WHAT DECK SHOULD YOU CHOOSE?

The superior finish in Honorwood deck, makes sure your entertaining areas and outside recreational areas last you the years you need it to with a minimum amount of care later. Remember no painting or staining EVER!

WHAT DOES THE WARRANTY NOT COVER?

It does not cover poor quality installation techniques which do not follow our installation tips or the Australian Standards which may result in cracking or bowing. This is not a timber deck so it has to be laid differently. It does not cover any sub floor movement which could be due to settling of the ground.

It does not cover ordinary wear and tear.

It is important to leave the correct expansion gaps between every joint or edge. It does not cover staining due the deck not being cleaned every 3 months with a pressure hose or similar. Remember bats, possums, ducks & bird droppings are usually very acidic & need to be cleaned off right away. Select your deck furniture right by not have small protruding legs that can jam inside deck joints or put pressure on hollow square clip faces of the deck.

The warranty does not cover acts of God or malicious damage

25 YEAR MANUFACTURERS WARRANTY

This Quality Warranty is promised by Huangshan Huasu New Material Science & Technology Co.,Ltd and the Honorwood products will not be destroyed by insects. The warranty also covers areas such as rot, chapping, crack or warp when the products are laid and used under the proper application. The warranty time is 25 years from the date of purchasing and is not transferable.

The warranty is only for decks used for domestic and commercial use and for use that the product was intended for. A deck is surface to get you from here to there & for sitting around & for walking or running etc. and attached to your home or business.

Warranty in the first 5 years is for the replacement or refund of the boards & clips only & does not include any labour, delivery fees or loss. Images will need to be supplied so that the manufacturer can approve the replacement within 30 days of the occurrence. Warranty is not transferable. After 5 years the warranty covers 60% of a board (6-8 years), 40% of a board (9-14 years) and 5% less for each year thereafter. If boards not available then dollar value.

THE CORRECT INSTALLATION

This information is not meant to be exhaustive. It is understood that you have some building experience. If not you should consult a professional or call the distributer or manufacturer. This deck is for on-land use. Deck is to be laid on good quality joists that are at 350 to 450 centres. The joist platform should be laser level with a slight run off so water does not pool on the deck. Posts are to have been concreted to the ground. When installing over concrete the joists should be bolted to ground. Deck is to be at least 35mm off the ground for ventilation and water should not pool under the deck. Use the correct clips to attach the boards to the joists. Where a join is in the deck boards then you have to double joisted to make sure that 1 x clip is only holding down 1 board on each side & not 4 corners and that one clip is on a full joist. A 4mm to 6mm gap should be left between all boards on all sides between every joint to allow for expansion when the deck is laid between 16 and 24 degrees outside temperature. Metal joists have a higher level of movement in heat then timber so be careful of that. The deck should not be left to overhang more than 20mm without support and the clip edge should be protected if the board is not concealed by an edge board. You can't walk on the 8mm clip edge so use an edge board or a composite corner or run it along the wall.

It is natural that the colour of products will have a some fading but after a period, the colour will normally not change substantially. Colours that are more susceptible to change are the dark browns or dark greys.
